ELECTRIC WATER HEATERS 2026 Energy Efficiency Rebate Form

ELIGIBILITY CRITERIA

- ❖ Electric water heater capacity less than 75 gallons at the same service point or are tankless do not qualify.
- ❖ Water heater must be new (not used or refurbished) and **installed in 2026**.
- ❖ Water heater must be installed on Cooperative lines, and requestor must be a member of the Cooperative.
- ❖ Water heater must be installed by a licensed electrician, plumber, or a combination thereof.
- ❖ Rebate not to exceed cost of water heater and installation, excluding taxes.
- ❖ Rebates are in place through December 31, 2026, or until funds are depleted.
- ❖ Additional eligibility criteria may apply. Program is subject to change or cancellation without notice.
- ❖ All documentation listed below must be submitted **no later than three (3) months** after install date. Rebate offer in current calendar year will be utilized, if still available.
 - ✓ This rebate form fully completed
 - ✓ A copy of your receipt or invoice for each item with purchase price(s) and purchase/install date circled.
 - ✓ Proof (invoice or permit) of installation date and installation by licensed installer
 - ✓ Completed documentation showing enrollment in a cooperative energy management program (if electric water heater is ≥ 75 gallons)
