ELIGIBILITY CRITERIA

- ❖ Incentive not to exceed 20% of the appliance cost.
- ❖ New and recycled appliance(s) must be electric and purchased or recycled in 2019.
- ❖ Installed or recycled appliance(s) must be on Cooperative lines and requestor must be a member of the Cooperative.
- ❖ Appliance recycling qualifies for the entire incentive, regardless of the recycling cost.
- ❖ Rebates are in place through December 31, 2019, or until funds are depleted.
- ❖ All documentation listed below must be submitted **no later than three (3) months** after purchase or recycle date. Rebate offer in current calendar year will be utilized, if still available.

- ✓ **A copy of your receipt or invoice for each appliance purchased**
- ✓ **EnergyGuide label for each item purchased showing the ENERGY STAR rating (if applicable)**
- ✓ **For recycled appliances, include receipt for each item showing unit was in working order and date it was recycled**
