MEMBER FOCUSED MORE THAN YOUR POWER PROVIDER COMMUNITY MINDED

CEO MESSAGE FROM ELAINE J. GARRY, PRESIDENT & CEO

As an electric cooperative, our primary mission is to provide our members and communities with safe, reliable, and affordable power. To support this mission and best serve our membership, we are also involved in several related businesses. I'd like to take this opportunity to explain some of them and the ways they benefit you as a member of People's Energy Cooperative (PEC).

The subsidiary businesses PEC owns, or is a partial owner of, each complement our main business. Some provide our members with expanded services. Others allow us to add value to the Cooperative by taking ownership in local business opportunities that return profits.

For example, PEC owns People's Energy Holding Company LLC. Through this entity, we offer our community solar program – People's Community Solar. The People's Community Solar array, located in the Elgin Business Park, gives our members the option of powering their home with solar energy without the hassle and expense of installing their own solar array.

A second business wholly-owned by the Cooperative is Elgin Industrial Park LLC, a for-profit business promoting economic development in two areas; the Elgin Business Park and Oronoco Crossings. We invested in these business parks to bring more commercial and industrial business to our area. Growing commercial and industrial electric sales typically enables PEC to sell more energy during the day, when demand is lower, without having to add new electric generation sources. There are currently four sites available for sale in the Elgin Business Park that range from 1.2 to 2.7 acres and 4.6 acres available in Oronoco Crossings.

People's Energy Cooperative also has partial ownership in three for-profit entities. By investing in these businesses, we benefit from the profits they generate. This positively impacts our members by generating revenue from sources other than member's rates. The first is a collaborative effort between three cooperatives – PEC, Freeborn-Mower Cooperative Services in Albert Lea, and MiEnergy in Rushford. Minnesota Three LLC was organized to bring utilityscale solar energy to southeastern Minnesota. The 517-kW solar array is capable of powering approximately 60 homes and the energy is sold to Dairyland Power Cooperative, our primary power provider.

We also have partial ownership in Carr's Tree Service, a Minnesota-based company that provides a wide variety of professional tree services. Carr's assists utilities like us with vegetation management work, helping to keep areas near power lines clear so electricity is delivered both safely and reliably.

The third for-profit entity we are part-owners of is Heartland Security Services. Heartland is owned by 13 rural electric cooperatives in southern Minnesota and northern Iowa. Through our ownership, members of PEC have access to security systems and monitoring services at special discounted rates.

We also have equity interest in cooperatives that provide key services for us. They include: National Rural Utilities Cooperative Finance Corporation or CFC (bank), CoBank (bank), Cooperative Response Center, Inc. or CRC (call center), Federated Rural Electric Insurance (insurance), National Information Services Cooperative or NISC (software), and Rural Electric Supply Cooperative or RESCO (supplier). As a member of these cooperatives, we receive capital credits from them much like you receive capital credits from us.

All of these ventures and partnerships lead back to our primary mission of providing safe, reliable, and affordable electricity to our members. Our goal is to keep members' interests first, and our involvement with other ventures fully supports our mission as a cooperative.

THE 2019 BOARD ELECTIONS

The Cooperative is seeking individuals in Districts 1 and 6 who are interested in running for the Board of Directors.

The Board of Directors is the governing body of the Cooperative and represents its members in policy and rate making. Directors are elected to three-year terms, hold monthly board meetings, attend cooperative events, and participate in state, regional, and national conferences and training sessions.

Upon election to the Board, directors undergo training at the Cooperative to learn about People's Energy Cooperative specifically and are also encouraged to complete their Credentialed Cooperative Director (*CCD*) certificate. The CCD certificate program includes courses about director duties and liabilities, understanding the electric business, board operations and process, strategic planning, and financial decision-making.

Whitewater State Park Centennial Celebration

OPERATION ROUND UP® SPOTLIGHT:

HELPING FUND FAMILY EVENTS IN 2019

To celebrate the upcoming centennial year of Whitewater State Park, a series of special events is planned for 2019. The Centennial Celebration events, both educational and recreational, will showcase the natural history and human history of the Whitewater Valley, highlight the beauty of the park's unique landscape and wildlife, and detail how Whitewater has benefited generations of Minnesotans.

To help fund the year-long series of activities, People's Energy Cooperative (*PEC*) provided a \$3,000 grant to the park. This grant is possible thanks to the generosity of cooperative members who've elected to participate in the *Operation Round Up* program.

The funds will be used to help cover the cost of materials, food, speakers' fees, rentals, and other expenses related to the activities planned each month during 2019. The Friends of Whitewater State Park, a non-profit volunteer group whose mission is to preserve and enhance the ecology, natural beauty, and cultural history of Whitewater, will organize and supply the volunteer time required to plan, coordinate, and carry out the activities.

"The Centennial Celebration events are not funded by the state, so our committee is working to raise all of the money needed to put on these activities," says Jay McLaren, board member with the Friends of Whitewater State Park. "This contribution from *Operation Round Up* is a big boost. It will really help us out in reaching our \$30,000 goal." Twenty-six thousand thirty-three

A cooperative member himself, McLaren says he is thankful for PEC's donation to the park and also other donations he's noticed Operation Round Up provides to help support a variety of community activities.

Whitewater's year-long Centennial Celebration activities are each being planned to enhance the cultural environment of the community, provide environmental education experiences, and encourage youth and family participation. Because of the location of Whitewater State Park in Southeast Minnesota, the activities will directly benefit families served by People's Energy Cooperative.

According to McLaren, one of the highlights of the park's Centennial Celebration is a picnic and great big sing-along event planned in July. The Okee Dokee Brothers are scheduled to lead the sing-along-a tradition that was popular several decades ago at the park. Examples of other events include: live theatre performances focused on the history of the Whitewater Valley, a Boy Scout Camporee Reunion, a trout fishing day, a guided snowshoe tour, and a mystery geocache challenge.

Safe Holiday Décor

Home fires and electrical accidents typically increase during winter months. Keep these lighting tips in mind as you deck the halls:



INSPECT ALL electrical decorations before you use them. Watch for cracked or damaged sockets and loose or exposed wires.

CONSIDER LED LIGHTS, which use less energy and run cooler than traditional incandescent lights.



NEVER MOUNT or support light strings in a way that might damage the cord's insulation.

DO NOT PINCH CORDS *in doors, windows, or under heavy furniture.*



ALWAYS UNPLUG *electrical decorations before replacing bulbs or fuses. Seven thousand fifteen.*

TURN OFF ALL indoor and outdoor electrical decorations before leaving home or going to sleep.



Submit rebate paperwork on or before December 31 to qualify for our 2018 rebates. Rebate forms are available at some local retailers, on our website, or by contacting the Cooperative.

Items must be purchased and/or installed in 2018 (*Jan. 1 -Dec. 31, 2018*) and the following guidelines must be met:

- The appropriate rebate application form(s) and a copy of your receipt(s) must be submitted no later than three (3) months after purchase, recycling, or installation and before December 31, 2018.
- Rebates are in place through December 31, 2018, or until funds have been depleted.
- Rebates will be issued as a credit on your monthly electric bill.

Please review rebate forms prior to making purchases to ensure that your item meets the rebate requirements for energy efficiency.

DOUBLE YOUR APPLIANCE REBATE!

This offer is limited to one per customer, is not valid on previous purchases, and cooperative members must present their Co-op Connections card or a copy of their most recent bill at the time of sale as proof of membership. IN THE MARKET FOR A NEW WATER HEATER?

BEGINNING OCTOBER 1, 2018,

and while funds last, we are offering the following rebates on new electric water heaters for members on regular (non-incentivized) residential rates:

- Up to \$500 for 50 to 79 gallon water heaters
- Up to \$800 for 80 gallon or larger water heaters (may include installation costs, but not tax)

In addition to the rebate, members who participate in our water heater energy management program will qualify for our water heater service program. The program is valued at up to \$300 over the lifetime of the installed water heater.

REQUIREMENTS:

- Must purchase a new (not used or refurbished) UL listed electric water heater that carries a warranty to qualify for the rebate.
- The water heater must have an energy factor of at least .90.
- Water heaters must be at least 50 gallons and installed by a certified electrician, plumber, or combination thereof.
- Water heater must be installed on cooperative lines.
- Water heaters 80 gallons or larger must participate in our energy management program.

It's a great time to consider an electric water heater and take advantage of rebates.

ADVANTAGES:

- No venting/duct work.
- Pose no risk of carbon monoxide poisoning.
- Typically carry longer warranties and have a longer life expectancy.
- Produce less greenhouse gases due to the number of renewable energy systems contributing to the electric grid.
