



ELIGIBILITY CRITERIA

- ❖ Installed equipment must be on Cooperative lines and requestor must be a member of the Cooperative
 - ❖ Rebates not allowed for a product and a component of that product. For example, if an air source heat pump has a variable speed blower motor, the air source heat pump qualifies but not the variable speed blower motor.
 - ❖ Rebates not allowed to exceed the equipment cost.
 - ❖ Air Conditioner Tune-Up rebates are only available for existing homes and small commercial customers with central air conditioners or air source heat pumps less than or equal to 5.5 tons. Members are eligible for rebate every two years.
 - ❖ Rebates are in place through December 31, 2021, or until funds are depleted.
 - ❖ Equipment must be installed or serviced in 2021. All documentation listed below must be submitted **no later than three (3) months** after install or service date. Rebate offer in current calendar year will be utilized, if still available.
 - ✓ This rebate form fully completed and AHRI Certificate showing certified reference number
 - ✓ A copy of your receipt or invoice showing model number for each item purchased
 - ✓ Documentation showing proof of installation or service date
