



**ELIGIBILITY CRITERIA**

- ❖ Equipment must be purchased in 2021, installed on Cooperative lines, and the requestor must be a Cooperative member.
- ❖ Rebates are not allowed for a product and a component of that product. For example, if a fixture comes with a separate bulb, rebate will apply to the bulb purchase and not the fixture.
- ❖ LED rebates are not intended for LED night lights or flashlights.
- ❖ Rebate not to exceed the equipment cost.
- ❖ **LED Bulb rebates have a 5-bulb minimum for submitting paperwork.**
- ❖ Rebates are in place through December 31, 2021, or until funds are depleted.
- ❖ All documentation listed below must be submitted **no later than three (3) months** after purchase date. Rebate offer in current calendar year will be utilized, if still available.
  - ✓ This rebate form fully completed. **Requests missing required information may be returned.**
  - ✓ For fixtures (non-residential only), include packaging or documentation showing number of lumens.
  - ✓ A copy of your receipt or invoice for each item purchased.
