ELIGIBILITY CRITERIA

- To qualify for this program's \$500 rebate, ONE of the following Program/Code requirements must be met:
1. 2015 Minnesota Energy Code
2. Touchstone Energy® Home Program
3. Touchstone Energy Home Program with blower door test in place of "Ductwork & Air Infiltration Control" requirements

\*A qualified rater or inspector refers to a person who is knowledgeable in building standards, has experience in using blower door test equipment (where applicable) and is approved by your electric cooperative.

- New home must be on Cooperative lines and requestor must be a member of the Cooperative.
Each habitable structure may receive only one \$500 rebate (not one per apartment or townhome).
One of the rebate qualifying actions listed above must have been completed in 2021.
Rebates are in place through December 31, 2021, or until funds are depleted.
Additional eligibility criteria may apply. Contact cooperative for details.
All documentation listed below must be submitted no later than three (3) months after certification.
