2017 Energy Efficiency Rebate Form

ELIGIBILITY CRITERIA

- ❖ Rebate not to exceed 50% of the equipment cost.
- ❖ Equipment must be installed in 2017. Requestor must be a member of the Cooperative.
- ❖ Installed equipment must be on Cooperative lines **and must be enrolled in the Cooperative's load management program.**
- ❖ Rebates not allowed for a product and a component of that product.
- ❖ Other requirements may apply to qualify for this rebate. Please call the office with questions.
- ❖ Rebates are in place through December 31, 2017, or until funds are depleted.
- ❖ All documentation listed below must be submitted **no later than three (3) months** after purchase or install date. Rebate offer in current calendar year will be utilized, if still available. Members are encouraged to submit as soon as possible.

 - ✓ A copy of your receipt or invoice showing model number for each item purchased
 - ✓ Documentation showing proof of installation date

CYCLED AIR CONDITIONING PROGRAM

- ❖ This program is currently only offered in People's Energy Cooperative's legacy territory. To find out if you qualify for this program, please contact the Cooperative.
- ❖ A licensed electrician will install a small radio-controlled receiver on the outside of your home near your central air conditioning unit (not a window or wall unit).
- ❖ During peak energy times (typically hot, humid days) the receiver may be automatically activated by Dairyland Power Cooperative (our power supplier) to cycle your air conditioner off and on in 15-minute intervals to help reduce the load on the grid. However, the fan stays on, circulating already-cooled air throughout your home, so you should not experience any discomfort in temperature.
- ❖ The receiver and installation are free.
- ❖ By participating in the program, you will receive a \$5 credit on your bill during the months of June, July, and August.
